Titus Bender, New Hope, Virginia is Professor Emeritus of Eastern Mennonite University. He, with his wife, Ann and their three children are compiling "stories" related to their experiences in the Freedom Movement in Mississippi during the 1960s.

Perry Bush is a Professor of History at Bluffton University where he teaches in the Department of History and Religion. He is the author of *Dancing with the Kobzar: Bluffton College and Mennonite Higher Education and Two Kingdoms, Two Loyalties: Mennonite Pacifism in Modern America*.

Erika Dyck is an Associate Professor and Canada Research Chair in the Department of History at the University of Saskatchewan. She is currently doing research into the history mental health facilities in western Canada, and is the author of *Psychedelic Psychiatry: LSD from Clinic to Campus* (2008).

John Elias is an organizational psychologist based at Saskatoon, engaged in development of mental health policy and delivery systems. He has been a clinician, planner, and administrator in the public system in Saskatchewan and is currently a consultant on indigenous peoples mental health, and has 30 years of experience with Mennonites in Canada, USA, Mexico, and South & Central America.

Kevin Enns-Rempel is the archivist at the Center for Mennonite Brethren Studies and Interim Director of the Hiebert Library at Fresno Pacific University where he also teaches in American history.

Frieda Esau Klippenstein is an historian with Parks Canada supporting National Historic Sites across Western Canada. Her interest in Oral History has led to interview projects with Mennonite women in Winnipeg, Mennonite villagers in Neubergthal, Manitoba, and First Nations elders both in northern British Columbia and across Saskatchewan.

Hai Yan (Ling Ling) Fan is a graduate student in multidisciplinary studies at the University of Lethbridge. She combined health sciences and anthropology in her master's studies to develop a more comprehensive view of health issues. Her thesis topic is: *Medical Encounters in "Closed Religious Communities: Palliative Care for Mennonite People."*

John J. Friesen is Professor Emeritus of history and theology at Canadian Mennonite University where in the past he taught in Mennonite and Hutterite history. He is the author of *Building Communities: The Changing Face of Manitoba Mennonites*.

Brian Froese is an Assistant Professor History at Canadian Mennonite University. He is currently finishing a book manuscript on California Mennonites forthcoming from Johns Hopkins University Press and undertaking a SSHRC-funded research project on Evangelicals and Mennonites in the Canadian West.

Edna Froese is a Continuing Sessional Faculty member in English at St. Thomas More College, University of Saskatchewan, Saskatoon.

Doug Heidebrecht, former president of Bethany College and Director of the Centre for Mennonite Brethren Studies in Winnipeg, is a missionary with Mennonite Brethren Mission, preparing for service in India.

Ann Hostetler is the author of *Empty Room with Light: Poems* and editor of *A Cappella: Mennonite Voices in Poetry*. She is Professor of English at Goshen College in Goshen, Indiana where she teaches literature and creative writing.

Helmut T. Huebert is a retired physician from Winnipeg who has published extensively in the history of Mennonites in Russia; his most recent book is *The David Hueberts of Margenau*.

Patricia Janzen Loewen, Ph.D., is Assistant Professor of History at Providence College, where she teaches Western Civilization, church history and Anabaptist Studies.

Grace Kehler is Associate Professor of English and Cultural Studies at McMaster University, Hamilton, Ontario. She principally works on British literature and culture of the Victorian era, publishing articles on period representations of opera and gender (the prima donna and the castrato) in both nineteenth-century journals and fiction. Her work appears in journals such as *Tessera*, *Essays in Theatre*, *Victorian Literature and Culture*, *Australasian Victorian Studies Journal*, and the *Victorians Institute Journal*.

Glen Klassen is an Adjunct Professor of Biology at Canadian Mennonite University in Winnipeg and before retirement he was Professor of Microbiology at the University of Manitoba. His present research interest is historical epidemiology of Mennonite communities. He has been associated with Eden Health Care Services in Winkler, Manitoba for the past ten years.

Sarah Klassen is a Winnipeg poet, fiction writer, and editor. Her latest books are *A Feast of Longing*, which received the High Plains Fiction Award, and *A Curious Beatitude*, which received the Canadian Authors Association Poetry Award. She has a new poetry collection scheduled for publication in 2012.

Elizabeth Krahn is a social worker and a practicing counsellor at Recovery of Hope in Winnipeg, Manitoba. She is currently completing her MSW at the University of Manitoba, with a thesis focusing on narrative approaches to lifespan and intergenerational effects of trauma.

Judith Kulig is a Professor within the Faculty of Health Sciences at the University of Lethbridge, in Lethbridge, Alberta where she teaches undergraduate and graduate students. Her research program is focused on rural health issues; she has conducted research among the Low German-speaking Mennonites for the last 15 years.

Neufeldt is an Emeritus Professor of Community Rehabilitation and Disability Studies, Dept. of Community Health Sciences, University of Calgary, residing in Toronto, and has published broadly on changes in mental health and disability fields. *In Pursuit of Equal Participation* is the title of his most recent book. He is a past chair of Mennonite Mental Health Services, and served on a variety of other MCC and church boards.
- Leonard Neufeldt, a literary and cultural historian, poet and editor, has retired with his spouse, Mera, to Gig Harbor, Washington. He was born and raised in Yarrow, BC.
- Steven M. Nolt is Professor of History at Goshen College. His most recent book, co-authored, is *The Amish Way: Patient Faith in a Perilous World* (Jossey-Bass, 2010); it is an exploration of "old order" spirituality.
- Tom Penner teaches in the Departments of English and Rhetoric, Writing and Communication at the University of Winnipeg and works as a freelance editor/copyeditor. His areas of research include postcolonial theory and Canadian prairie literature.
